After a crazy year that saw us cancel our event for the first time in our history, we are excited to be busy planning the 2021 Orange County Special Angels Rodeo. Our team continues to grow and adapt to meet the needs of hosting a successful and growing event. Sponsors and volunteers are preparing to help us bring an even bigger and better event this year. We hope that you will be a part of that continued growth.

This year's Rodeo will be Saturday, November 13th, 2021. Registration will open at 9:00am and participants will be assigned a buddy at that time. Events and activities will kick off at 10:00am as in prior years with our opening ceremonies. We will be returning to T2 Arena and Event Center, located at 3810 Old Peveto Road in Orange, Texas. Old Peveto Road runs between FM1078 and FM1130 north of Orange.

The Special Angels Rodeo is open to participants of all ages and will serve people with Intellectual and Developmental Disabilities including Autism, Downs Syndrome, and others. It is also open to participants who are visually impaired or are in wheelchairs or otherwise affected by to multiple sclerosis, muscular dystrophy, spina bifida, traumatic injury, or other ailment, whether physical, intellectual, or developmental. Each event can be adapted to the needs of each of our participants, whether it be hands on assistance from one of our many volunteers, a specially designed trailer pulled behind an ATV to move them and their wheelchair through the arena dirt, or any other necessary modification. This event is like no other in this area and will touch the lives of countless unreached Special Angels. The best part about the Special Angels rodeo is everyone is a winner and there is no cost to take part. We also have carnival style games and other activities available for our participants and their families. Each participant in the Special Angels Rodeo will receive a T-shirt and other items in addition to a medal to commemorate their participation.

We are currently in the process of lining up first responder agencies, businesses, civic, school, and church organizations to volunteer their services on the day of the event. Our committee is working hard behind the scenes to plan the events, build or purchase any needed items, and make any other necessary arrangements to make this rodeo an even bigger success than our first two years.

In consideration for participating in the Orange County Special Angels Rodeo and other valuable consideration, I hereby release, waive, discharge, and covenant not to sue the Orange County Special Angels Rodeo, its officers, boards, committees, servants, agents, employees, members, volunteers, sponsors, partners, affiliates, and their heirs, assigns, and personal representatives (hereinafter referred to as Releasees) from any and all liability, claims, demands, actions, and causes of action whatsoever arising out of or related to any loss, damage, or injury, including death, that may be sustained by me or my child, or to any property belonging to me or my child, whether caused by the negligence of the releasees or, or otherwise, while participating in such activity, or while in, on or upon the premises where the activity is being conducted or in transportation to and from said premises.

To the best of my knowledge, I or my child can fully participate in this activity. I am fully aware of the inherent risks and hazards to all persons participating in, volunteering with, or viewing this activity, including all events and activities, and I choose to voluntarily participate in said activity, and to enter the premises and engage in such activity knowing that the activity may be hazardous to me and my property. I voluntarily assume full responsibility for any risks of loss, property damage or personal injury, including death, that may be sustained by me or my child, or any loss or damage of property owned by me or my child, as a result of being engaged in such an activity, whether caused by the negligence of releasees or otherwise.
